

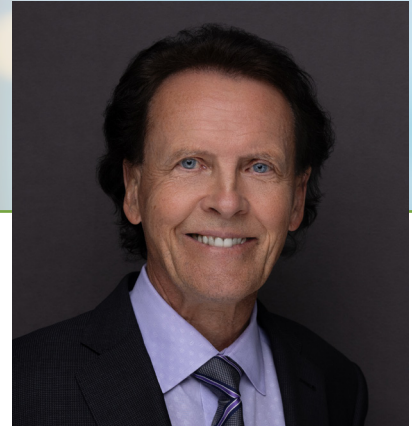

KENNETH HOROHO, JR. is a partner at Pietragallo Gordon Alfano Bosick & Raspanti, LLP, where he is the Chair of the firm's Family Law Practice Group.

Mr. Horoho is one of Western Pennsylvania's preeminent family law attorneys, having been involved in some of the region's most complex equitable distribution, divorce, and custody cases over the past three decades.

Mr. Horoho's reputation as a family law advocate and problem-solver have earned him numerous distinguished appointments from the governor of Pennsylvania, the Supreme Court of Pennsylvania, the Pennsylvania Bar Association, the Allegheny County Bar Association, and several prominent universities and community organizations. In 2021, he was appointed by the Pennsylvania Supreme Court to its Domestic Relations Procural Rules Committee (DRPRC) which advises and assists the Court on matters relating to the practice of family law in Pennsylvania. He recently completed his year as Vice Chair of the DRPRC. In 2009, he was appointed by Supreme Court Chief Justice Ron Castille to the Interbranch Commission on Juvenile Justice; a special panel created by Governor Edward Rendell and the Pennsylvania General Assembly to investigate the causes of one of the most extraordinary cases of judicial corruption in state history. In addition, Mr. Horoho served as the 112th President of the Pennsylvania Bar Association ("PBA").

In addition to serving as President, Mr. Horoho has held other roles in the Pennsylvania Bar Association, including serving on its Board of Governors, Chair of its Young Lawyers Division and on the Executive Counsel of the Family Law Section. He has also been very active with the Allegheny County Bar Association serving as a former member of its Board of Governors, Chair of the Young Lawyers Division and Chair of the Family Law Section.

Mr. Horoho has been recognized by the 2026 *Chambers High Net Worth* Guide in the area of Family and Matrimonial Law in Pennsylvania. In addition, Mr. Horoho was recognized by his peers for his divorce and family law practice by being selected to Woodard- White's 25th Anniversary Edition of *The Best Lawyers in America*® and has been recognized in *The Best Lawyers in America*® since 2007, as well as the *Pennsylvania Super Lawyers* list since 2004. Further, he was recognized as an Honoree of *Irish American Legal 100*. In 2010, Mr. Horoho was the recipient of the Saint Francis University Bel Cuore Award. He has also received the YMCA Service to Youth Award and the Allegheny County Bar Association's Outstanding Young Lawyer Award.

Mr. Horoho served 13 years as an adjunct professor on the faculty of the University of Pittsburgh School of Law where he taught Advanced Family Law Trial Advocacy. He is a frequent lecturer for the Pennsylvania Bar Institute, the Pennsylvania Bar Association, and the Allegheny County Bar Association on topics of divorce, support, equitable distribution, and custody. Mr. Horoho served 12 years on the Saint Francis Board of Trustees

and has been a member of the Duquesne Law School's Dean Advisory Board since its inception. Since 2023, he has served on the Neighborhood Legal Services Board of Directors and, in 2026, he was elected President of the Neighborhood Legal Services Board of Directors.
