Mr. Soller successfully argued on behalf of Appellants in the Pennsylvania Supreme Court case of *Schwartz v. Rockey*, 593 Pa. 536; 932 A.2d 885; 2007 Pa. LEXIS 2177, which defined the standard for an award of treble damages under the Pennsylvania Unfair Trade Practices and Consumer Protection Law, as well as establishing the standard in Pennsylvania for the election of damages versus equitable remedies.
